Due to the lack of consistent timer locks it was agreed that Cllr Moyle would unlock the toilets and leave them open pending any issues. Architect/ agent for this property provided a quick summary of their new application in light of the appeal decision not to allow the removal of the sycamore tree on the site boundary. The design of this would be more in keeping with the existing properties surrounding the site (Avalon/ Hedgerows) and would in effect build 'around' the tree. The reason for this presentation was the August deadline on the current single dwelling planning permission. 1975. TO RECEIVE INFORMATION ON THE PURCHASE/INSTALLATION OF A COMMUNITY DEFIBRILATOR

Presentation from Louise Jones: 8 members of the parish are now CPR trained. A defibrillator is very important in our aging village. All the school and shop staff she has spoken to are willing to be trained up in its use. Ideally it would be situated outside the pub (issue with listed building status?). If bought through Falmouth Coastguard Association it would be maintained, insured and have replacement consumables supplied within the £1500 cost. If the defibrillator is stolen it will be replaced within 12 hours. There is the option of a deterrent 'strap' across the box – it is big enough to deter tampering but quickly removed for use.

Although Louise has signed up to be a community first responder , there is a waiting list for training and she may well fall down this depending on who else signed up countywide.

A member of the public asked why it has been decided to install on the Pub – would not the surgery be better? The pub was just an initial suggestion since Louise has been in contact with them and it seemed an obvious and visible sport in the village. It was not the final choice.

Fundraising by the Fun Run committee had been offered, but this would not be available until September.

It was proposed by Cllr Moyle, seconded by Cllr Barnicoat and **RESOLVED** that the Parish Council would fund the immediate purchase of a defibrillator at £1500 and if any additional fund-raising monies were to come in they could pay back this contribution.

University of Falmouth numbers set to rise 8000 by 2020. Article 4 status for Falmouth still being looked into. May lead to an increase on pressure for student housing outside of the main Falmouth/Penryn area.

£8000 grant available for Neighbourhood Development Plans. Plans do not have to cover whole spectrum, they can now focus on a single areas if we still want to be involved. It has been noted that they will be given increasing weight in Cornwall Council decision making the further along the process councils are.

Cllr Sadler explained that the problem we had was that it was a very time consuming project and the volunteers we had from the general public were not able to commit to such a long term project without a driving force behind them. Falmouth Town Council's NDP has been challenged as there was little or no input from adjacent parishes/communities.

Cornwall Local Plan – sent back by Secretary of State. Wants to see the projected number of houses increase (from 47500) to include the need for 2nd homes and a realistic target for affordable homes.
