**RESOLVED** that whilst generally supportive of this application Mawnan Parish Council are concerned that there is no mention of foul water provisions. As we are well aware there are usually maintenance works done over winter to boats in storage that, being well within the Helford SAC,, has significant potential for contaminated water etc to find it's way into the surrounding pasture at least.

We would ask that strict conditions on the disposal of waste water & maintenance byproducts be included should this application be approved.

**RESOLVED** that Mawnan Parish Council support this application for obscured glass but still remain unhappy with the use of cladding on a building noted within our NDP for it's 'dressed killas rubble & granite construction ...a fine example of pre-WW1 construction'.

on a vote being taken the matter was approved unanimously

## Ref. No: PA21/10933 | Brynn Cottage Mawnan Smith TR11 5JZ

The agent was given time to speak on this application and to read out a statement from the homeowner. Statements from the immediate neighbour JN and MW, a resident at a neighbouring property, were read bout by them both. Comments were received from councillors who had attended the recent site visit to the property and discussed.

It was proposed by Cllr Sadler seconded by Cllr Whibley &

**RESOLVED** that Mawnan Parish Council objects to this proposal – mainly due to the scale and impact of the 2 storey addition and the 'out of character' design. Almost all of the dwellings in the immediate vicinity are included within our (draft) NDPs Non-designated Heritage Asset list with Brynn Cottage being included in a tied listing with its conjoined neighbour, Trebah Wartha.

There are significant concerns that the increase in height of the extension would have a detrimental effect to the unique, public views of Tower House and its chateau style roof. It is also felt that the use of vertical wooden cladding, large glazing panels & vertical louvers, especially on the entrance facing aspect where it would be seen from the road, would be inappropriate in this setting and significantly detract from the current shared façade of the semi-detached cottage and its neighbour at Trebah Wartha – the joint building being natural stone and dressed granites.

We feel that this plan as it stands would go against not only the spirit of Policy 3 and

Policy 5 in our own (draft) NDP but also be in opposition to the AONB Management Plan (Policy MD9) and the revised 2021 Cornwall Design Guide (Policy 5) as it relates to local historical context.

on a vote being taken the matter was approved unanimously

Ref. No: PA21/11094 Chygwyn Sampys Hill Mawnan Smith TR11 5EW

It was agreed to make a site visit to this property tomorrow morning so the neighbour's comments on proximity and overlooking could be seen from the site itself and considered in relation to the existing dwelling. The clerk would be contacted with the vote of those attending to record by noon.

We would however like a condition tying the store building to the main house as ancillary accommodations so that there is no potential for it being split off into a separate entity.

**RESOLVED** Mawnan Parish Council support this application. We understand that the balcony, since created, has been prone to leaks and feel that the change to a pitched roof is a conscious decision to address this with as little impact to the new facade of the dwelling as possible

This request was discussed at length and it was agreed that it should be made clear that if supported this grant would be the last for 'capital' costs for the foreseeable future and any future grants would rely very heavily on the Anvil Trust showing a more intensive programme of fundraising / outside grant application that appears to be taking place at present.

The clerk stated that there was only about £3200 left in the Donations & Grants pot for this year and that anything above this (with a grant request for Coastwatch, project total £1800, tabled for January) needing to be agreed to come from General Reserves.

It was proposed by Cllr Whibley seconded by Cllr Bate &

**RESOLVED** that an award of £5000 (£1200 coming from reserves) be made but that active fundraising activities needed to be shown to be taking place before any future Parish Council grant would be considered.

Mr Damer (NDP Steering Group chair) spoke to explain the outcome of the NDP Examiner's report and recommendations and the changes this would require making to the draft NDP documents. He said that so far a response had been given by the PC on the recommendations from the Examiner but that there was 1 issue remaining unaddressed. This response had been sent to Cornwall Council and an informal acceptance of this made – James Evans was currently making the agreed changes and modifications to our NDP documents. It was hoped to have these changes made before the New Year for submission to keep on track with a likely referendum date of April 2022. From this point on however our draft NDP now has full planning weight behind it and Rob Lacey (CC Policy Team) had passed this through to the planning team. It was unfortunate the CIIr Bradley was unable to attend and had not submitted his full report on the meeting with Viv Bidgood (CORMAC).

Cllr Sadler summarised:

- the pedestrian crossing at Grove should be taking place soon.
- Repainting of dragon's teeth at the top of Grove Hill was to be added to the maintenance schedule.
- Parking along Carwinion Field gate not a big priority for enforcement as cars leaving the site would be across the road before being seen but going at such a slow rate of speed accidents were unlikely.
- Lowenna pavement road assessed as wide enough for one to be put in but there would still be issues with on-street parking, especially when hall events were taking place. There was an obvious 'sticking point' just below the garage currently.
- Lamanva crossroads it was felt that this should have something done to address the number of accidents and near missed that were taking place – Cllr Sadler thought the majority of these were cars coming up from Argal.

#### 3502.21 REPORTS FROM OTHER GROUPS / INDIVIDUALS

Cllr Sadler summarised notes made following a Graveyard Committee meeting for necessary works.

**3503.21 REPORT FROM CORNWALL COUNCIL WARD MEMBER** (this item was done following item 3490.21 because Cllr Bastin was needed elsewhere)

- Cllr Bastin noted that cases of covid were coming down in our area but that boosters were still necessary as Omicron took hold.
- An additional 18 emergency accommodation pods were being put in behind Penryn Jobcentre.
- A lane on the ASDA bypass would be closed until Feb 25<sup>th</sup> for bridge works speed reduction also in place.
- The Cabinet at Cornwall Council had states that there was a £55 million shortfall in next year's budget proposals. Currently they were looking at making staff redundancies and this would affect Adult Social Care despite funding for this being earmarked. Cllr Sadler asked how this has happened it was in part due to the last administration leaving holes within the system that had not shown up to now and did not relate to any cuts from central government. The CC budget had to be balanced by 1<sup>st</sup> April.
- 20 is plenty trial of all 30mph areas reducing to 20 in settlements is to start at selected locations from the beginning of April for a 6 month trial period. If this proves successful it would be rolled out across the county. Falmouth/Penryn network area agreed as part of the initial trial more info to follow as received.
- Next CNP meeting on 25<sup>th</sup> January anyone in the parish is welcome to attend with meeting still being held online. Clerk was asked to advertise joining instructions.
- The bill requesting a declaration of an Eco-emergency was passed with full support by Cornwall Council at start of month.
- A resident requested that Cllr Bastin look into getting a rubbish bin put in at the Penwarne layby as it was obvious it was being used as a frequent stopover for drivers, since the parish had been refused one.

#### Dear Mrs Clements

Following my previous email (23<sup>rd</sup> November 2021) I've now surveyed footpath 19 in order to put together a design for improvement works. As you know, the main problem here is the lack of drainage. In order to effectively drain the path we need a suitable carrier (e.g. surface water channel), enough of a slope to move the water and an onward destination. The path is relatively level, narrow and hemmed in by the gardens and the field boundary, so meeting these requirements will not be straightforward. Access for physically doing the work is also problematic, with the several granite stiles throughout. Without effective drainage, water will continue to pool on the path despite any efforts made to improve the surface itself.

I will investigate the options, in discussion with the National Trust, although it would be helpful for me at this stage to get a good idea of the PC's hopes for this path. In particular, with reference to:

- Type of path surface e.g. bound urban (tarmac) or unbound rural (loose stone)
- Extent of the work i.e. same standard from the allotments to Carwinion Lane, or not
- To retain the granite stiles, or not
- Some seasonal waterlogging acceptable, or not

Answers to the above, and any other suggestions or concerns you may have, would be much appreciated. It may not be possible to achieve every possible goal here, however I will look into the options available.
